JUDGING:

Entries will be judged on originality, team spirit, construction & costumes. Team must finish the course with all team members on the craft at the finish line to win.

AWARDS:

Prizes will be awarded to the top three teams in the adult and junior divisions. All participants will receive a one hour pass to visit Cannonball Snow Tubing at a later date.

DETAILS:

- * All Cardboard Derby crafts must be constructed of cardboard, tape, string, glue & paper. Wood, metal, fiberglass & rigid plastic are not permitted. The judges reserve the right to disqualify any craft if the craft is deemed to be unsafe for the participants or spectators.
- * Teams may consist of up to 5 members. All members must remain on the craft for the entire run.
- * All Participants must sign a release form to participate. Members under the age of 18 must have a parent or guardian signature. Under no circumstances will anyone be permitted to participate without a signed release form.
- * Helmets are required.
- * Please dress appropriately for winter weather. There is no shelter at the top of the course.
- * Participants agree to allow Ski Roundtop & WJTL to use photos of the participants & crafts for promotional purposes.
- * Teams are responsible for removing their crafts from the property after the event.
- * The decisions of the judges are final.

Cannot exceed 5.5' wide / 6' high / 10' long
Weight Restrictions: Racer must have carrying handles so that team members can lift & carry the racer 100 yds.

**SKI ROUNDTOP CARDBOARD DERBY COMPETITION
RELEASE & ASSUMPTION OF RISK AGREEMENT**

NOTICE OF RISK

I, the undersigned, do hereby understand, acknowledge and agree that winter snowsports, including Cardboard Derbies are dangerous sports with inherent risks that could lead to permanent catastrophic injury or death. These risks could include, but are not limited to traveling at high rates of speed, variations in terrain, ice and icy conditions, lift and snowmaking towers, utility lines and poles, fencing, snowmaking and grooming equipment and component parts, and other forms of natural and man-made obstacles on and off the designated runs, as well as collisions with equipment, fencing, or other participants, and varying conditions due to weather changes and use. I further understand, acknowledge and agree that participation in a Cardboard Derby competition is potentially dangerous and contains additional risks other than those listed above.

I, further agree to accept the facility as is, and understand that I may inspect the course or run prior to any use of the same.

ASSUMPTION OF RISK

Understanding, acknowledging and agreeing to all the risks involved, I or my minor child are voluntarily participating in the aforementioned event, and I agree to assume for myself or my minor child, all the risks involved.

RELEASE FROM LIABILITY

In consideration of being allowed to participate in the above mentioned competition at Ski Roundtop, I **HEREBY AGREE NOT TO SUE, AND TO RELEASE SKI ROUNDTOP OPERATING CORP., AND SNOW TIME, INC., WJTL RADIO, AND CREATIVE MINISTRIES INC., AS WELL AS THEIR AGENTS AND EMPLOYEES FROM ANY AND ALL LIABILITY, RELATED TO MY OR MY CHILD'S PARTICIPATION OR USE OF THE FACILITIES, REGARDLESS OF ANY NEGLIGENCE ON THE PART OF THE SKI AREA.**

I FURTHER AGREE TO HOLD HARMLESS, INDEMNIFY AND DEFEND THE SAME, FROM ANY CLAIM RELATED TO MY OR MY CHILD'S PARTICIPATION IN THIS EVENT OR THE USE OF THE FACILITY, REGARDLESS OF ANY NEGLIGENCE ON THE PART OF THE SAME.

As a competitor or parent/guardian, I understand and agree that this agreement constitutes a contract and may negate my ability to bring suit or recover any damages related to any claim that I may have. I further understand and agree that this agreement is binding not only to myself, but also my heirs, executors, administrators and assigns, and I herewith again reaffirm my free and willful intent to execute it.

I further agree that in consideration of being allowed to participate, I am granting Ski Roundtop permission to use my photograph, videotape, motion picture or any other record of my use of its facilities for legitimate purposes.

I agree that all disputes arising under this contract shall be litigated exclusively in the Court of Common Pleas of York County, PA or in the United States District Court for the Middle District of Pennsylvania.

This agreement is governed by the applicable laws of this state. If any part of this agreement is determined to be unenforceable, all other parts shall be given full force and effect.
